Eight Individuals File as Candidates for Board Positions for

South Suburban Park and Recreation District's May 6 Regular Election

Eight individuals have filed as candidates for Board of Directors positions for South Suburban Park and Recreation District's Tues., May 6 election. There are three openings on the five-member board. The incumbent candidates are John K. Ostermiller, Pam Eller and Mike Anderson. Board members Sue Rosser and Scott LaBrash will continue to serve their terms, which are scheduled to expire in May 2016.

Candidates for the three, four-year terms are Sally Daigle, John Watson, Travis Nicks, Tom Wood, John K. Ostermiller, Pam Eller, Stan Szabelak and Mike Anderson. Voters will be instructed to vote for three candidates. There are no other ballot questions. Special District elections are non partisan elections. Members are elected to serve the District at-large.

The polling place located at Goodson Recreation Center is designated as the polling location for eligible electors not residing within the District.

An eligible elector is a person who, on election day, is registered to vote in the State of Colorado; and either who is a resident of the District or who owns taxable real or personal property (or the spouse or civil union partner of owner) situated within the boundaries of the District, or a person who is obligated to pay taxes under a contract to purchase taxable property within the District.

Applications for absentee ballots are available and may be obtained at the Administration Office, 6631 S. University Blvd., or can be downloaded from the South Suburban website, www.sspr.org, or to have an application mailed to you, you may call 303-798-5131. Applications will be accepted until the close of business at 5 pm on the Fri. immediately preceding the election, May 2, 2014. The ballot drops off boxes are located at Buck Community Recreation Center, Goodson Recreation Center and Lone Tree Recreation Center, 10249 Ridgeway Cir., Lone Tree.
